The test will be held on **Monday, February 3<sup>rd</sup>, 2025**, at Bulverde Spring Branch Fire and EMS Station 71, 353 Rodeo Drive, Spring Branch, Texas 78070 at 0900.

The Training Officer Exam is a knowledge-based assessment of 100 questions from the following source materials:

- *Brannigan's Building Construction for the Fire Service, 5th ed.,*
- *Fire and Emergency Services Company Officer, 6th ed., IFSTA*
- *Structural Firefighting Strategy and Tactics, 4th ed.*

**Formal Interview:**

All applicants who successfully pass the written exams will receive an invitation **by email** with the date and time for the formal interview.

The Bulverde Spring Branch Fire and EMS Department is committed to maintaining effective communication in all its transactions. Members will be notified of their eligibility status throughout the promotional process.
